The Grand Encampment of Knights Templar U.S.A. and Its Jurisdiction PHA, Inc. is the national governing body of the Prince Hall Knights Templar, an integral part and Christian-oriented member of the York Rite of Prince Hall Masonry.

The Inter-State Conference of Knights Templar, which was a precursor to the Grand Encampment, was formed August 17-22, 1908, on a biennial basis in Chicago, IL with representatives from the Jurisdictions of Indiana, Kentucky, Michigan, Tennessee, Missouri, District of Columbia, Texas, Kansas, Louisiana, Ohio, Pennsylvania, and Illinois. The Jurisdiction of Canada expressed a desire to join so the name was changed to the International Conference of Knights Templar. The object of the Conference was to promote uniformity of ritual, drill tactics, standardization of Templar uniforms and insignia, and to bring the Fraters into a harmonious whole and inspire them in greater pride in the history and lessons of Chivalric knighthood. Many were permanent results of this Conference. Past Right Eminent Grand Commander James Francis Rickards (MI) was elected the first President. He was later the Sovereign Grand Commander of the United Supreme Council, AASR, Northern Jurisdiction 1911-1921. During the Biennial meeting of International Conference of Knights Templar on August 21, 1926, in Philadelphia, PA, the members voted unanimously to change the organization's name to the Grand Encampment, Knights Templar of North America, Prince Hall Affiliated. Past Right Eminent Grand Commander Albert R. Lee of Illinois was elected the first Most Eminent Grand Master. The rest of the first elected officers of the Grand Encampment were as follows: R.E. Sir Levi Williams (NY), Grand Generalissimo; R.E. Sir Joseph Minor (DC), Grand Captain General; R.E. Sir Joseph Evans (MD), Grand Treasurer; R.E. Sir William H. Perry (KY), Grand Recorder; R.E. Sir William S. Lewis (PA), Grand Senior Warden and R.E. Sir Charles Gordon (OH), Grand Junior Warden.

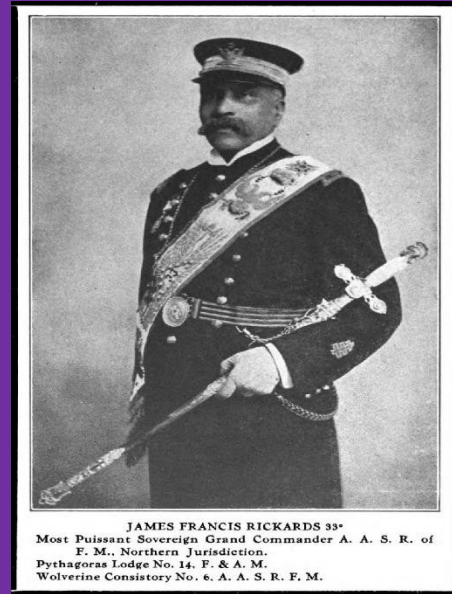
